## TENURE TRACK FACULTY POSITION ANNOUNCEMENT

The Department of Accounting (<a href="https://fae.uprrp.edu/contabilidad">https://fae.uprrp.edu/contabilidad</a>) in the College of Business Administration at the University of Puerto Rico, Río Piedras campus announces a search to fill a tenure track faculty position in the area of managerial accounting effective on August 1, 2024.

Requirements: Applicants must have a Ph.D. in Accounting from an accredited university whose degree is recognized by the University of Puerto Rico. The second preference is a terminal degree in Accounting or an area related to Accounting from an accredited institution whose degree is recognized by the University of Puerto Rico. The candidates must possess a professional certification as a Certified Public Accountant (CPA) or equivalent certifications. It is preferable that candidates have publications in their area of expertise in recognized peer-reviewed journals that meet the college's guidelines (or work in process for recent graduates). Preference will be given to candidates with experience teaching managerial accounting or accounting information system courses at the university level. Data analysis, information systems, and forensic accounting are expected to be integrated into the teaching of accounting courses. Candidates must demonstrate commitment to excellence in teaching, knowledge of the use of educational technologies, and the ability to offer online courses. Proficiency in both Spanish and English is required. It is expected that the selected candidate will develop proposals to obtain external funds.

**Responsibilities:** To teach undergraduate and graduate-level courses during daytime, evening, or weekend hours in face-to-face and online format; conduct research and publish in their areas of expertise in recognized peer-reviewed journals as defined by the college's guidelines; supervise students that are doing research work or professional practices; develop proposals seeking and raising of external funding; actively participate in committees, in departmental and university life, in service of positive impact on the community, as well as comply with all the responsibilities of the teaching staff contained in the General Regulations of the UPR.

The deadline for applications is May 3, 2024. Applicants must send via email: 1) letter of intent in which they describe their academic vision and research and publication areas 2) up-to-date curriculum vitae; 3) official academic credentials of all their degrees (diplomas, certifications, and transcripts); 4) evidence of their research, publications, and creative work; 5) two recommendation letters to the attention of Dr. Rafael Marrero Díaz, Dean of the College of Business Administration of the University of Puerto Rico - Río Piedras Campus.
